  - Another province.
- 7. Other professional affiliations, including positions held.
- 8. Community service:
  - Name of organization(s);
  - Position(s) held;
  - Length of service.
- 9. Conference or Technical papers given or published:
- 10. Candidate Statement

- 1. Material will be published in the above order and under the headings specified.
- 2. If a candidate puts nothing under a specified heading, the heading will be deleted from the printed statement.
- 3. If the total word count exceeds 450 words and time does not permit revision by the author, after the material has been placed in the required order any excess words will be removed from the end of the material.
